



GUIDELINES FOR SUBMITTING ACTIVITIES PROPOSALS

Please only send if you really want to participate in the event

Activities proposals for the I CINEAI and VI COBEAI can be in the following modalities:

- Short course
- Workshop
- Lecture
- Round table
- Book release
- Artistic presentation
- Art exhibition
- Exhibition of scientific products
- Video display
- Technical visit (only for institutions)

Minicourse: Must be on a theme related to Environmental Education or Environment. Materials and equipment should be the responsibility of their creators. It will have a total workload of 4 hours.

Workshop: It must be about a theme related to Environmental Education or Environment. You must develop some skill or experimentation with the group. Materials and equipment should be the responsibility of their creators. It will have a maximum time of 4 hours.

Lecture: It should be about a theme related to Environmental Education. You can express the result of research or experience. It should have a maximum duration of 1 hour, followed by a debate for up to 30 more minutes.

Round Tables: Must be on a topic related to Environmental Education or the Environment. At least two panelists must participate. The formation of the table and the work dynamics must be defined by the participants. You will have a maximum total time of 2 hours; 1 hour of presentations, followed by 1 hour for debate.

Book launch: It must be about a theme related to Environmental Education or Environment. Re (launches) may occur. Materials and equipment should be the responsibility of their creators.

Artistic presentation: Any of the artistic modalities: visual, scenic, music, dance, etc. It can be individual or group presentation.

Artistic exhibition: Must be on a theme related to Environmental Education or the Environment. It can be in any kind of arts (plastic, scenic, musical, etc.). Equipment and transport are the responsibility of its creators.

Exhibition of scientific products: Must be on a theme related to Environmental Education or Environment. It may be in any of the areas of knowledge (technological, human, natural, exact, social, health, etc.) or interdisciplinary. Equipment and transport are the responsibility of its creators.



Video Exhibition: It must be about a theme related to Environmental Education or Environment. It must have a maximum duration of 3 hours. Equipment and transport are the responsibility of its creators. We will make Datashow available.

Technical visit: It must consist of a guided and accompanied visit to an institution or company that develops activities related to environmental preservation or Environmental Education. The institution must provide transportation. It should last a maximum of 3 hours.

ATTENTION:

- Registration for Oral Presentation, abstract submission, display of banners and participation as a Listener, will be available only after the program has been announced.
- A single proponent may submit up to three activity proposals, provided they are not of the same type.
- The I CINEAI is not responsible for displacement, transport, accommodation, installation, or equipment of the proponents.
- Due to the self-financing of the event, there is no provision for subsistence allowances or any type of payment for the proponents of the activities.
- Some Activities may be proposed in remote format, as long as the proponent has the technical and equipment conditions for synchronous online transmission.
